I am not aware of any physical condition, which would prevent my child from engaging in any physical activity. You are certifying that you have read the waivers and agree to their content and conditions they set. You agree The Studio for the Performing Arts, Inc., will not be responsible or liable to you or your estate for any injury accident or loss of personal property. You understand that you cannot transfer this membership to any other person. You do hereby release this facility and its employees from any claim or cause of action which may occur as a result of any medical problems known or unknown which you have knowledge presently or in the future. It is understood that these programs involve physical activity. You acknowledge that and assume full responsibility for any and all physical injuries which the above participant t may sustain as the result of participating.

General: You acknowledge that SPA staff is not responsible for yourself or the participant while he/she is not in class, that your arrangements will include the process going to and from classes. You verify no promises or guarantees, other than those written in this agreement were made to you by this facility or its employees. **You agree to follow guidelines and to cooperatively utilize the facilities with other participants and understand failure to do so may result in cancellation of this contract without refund of any fees.**

Financial: Your signature acknowledges you are financially responsible for any and all payments as listed on the registration form or any payment plans you agree to. You can at any time determine to stop your participation in SPA Dance program however, **a 30 day written cancellation statement signed by you (dated before the 1st of the month or you will be financially responsible for that month's fees), is required and may be dropped off or mailed. If items have been purchased for your student/yourself such as costumes, competition fees, etc. you will remain financially responsible for full payment of these fee(s). If you do not submit a written cancellation you will be charged as if you are still actively participating, until such notice is received. Our dance contract is based on 9 months of instruction. In consideration of recital preparation no cancellations will be accepted after *April 1st You will remain responsible for April and May tuition payments if you are currently enrolled*.**
